PURPOSE

The Generations Credit Union Scholarship Fund was established in 2014. This scholarship will be awarded annually up to \$1,000 to a student residing in Winnebago, Ogle, Stephenson, Boone or DeKalb County – who is planning to pursue a two or four-year degree at an accredited college, university, trade or vocational school or apprenticeship program who demonstrates, through their community involvement, a strong commitment to improving the quality of life for people in their community.

SCHOLARSHIP AWARDS

The Generations Credit Union Scholarship Committee awards scholarships on the basis of a comprehensive process. Areas that are reviewed by the committee include, but are not limited to the following: Academic Accomplishments, Community Service, References, and Financial Need. The Generations Credit Union Scholarship is awarded without regard to age, race, religion, color, ethnicity, gender or sexual orientation.

CRITERIA

- Applicants must have permanent residence status in Boone, DeKalb, Ogle, Stephenson, or Winnebago County, Illinois.
- Applicants completing high school must have a minimum GPA of 2.5 on a 4.0 scale.
- Applicants must be accepted as a student at a college, university, or trade school program for the upcoming academic semester. If scholarship money is awarded, this is the only program that will receive the funds on behalf of the applicant.
- Applicants must demonstrate a need for financial assistance.
- Preference will be given to members of Generations Credit Union and non-traditional students.
- Applicant must be enrolled in a minimum of 12 credit hours or full-time equivalent.

SCHOLARSHIP APPLICANTS MUST PROVIDE:

- Completed application form.
- Official high school transcript or college transcript in a sealed envelope from the institution.
- Two academic references from a guidance counselor or teacher **OR**
- A reference letter from an employer or other community member.
- Proof of acceptance at an academic, vocational or technical school for post-secondary studies.
- Demonstrated financial need.

Deadline for the application is **June 15, 2019**. Applications postmarked after this date will not be considered.
